2. Each Ale Trail on the app including the "World's Biggest Ale Trail" is run by The Cask Marque Trust Ltd.
3. The Cask Finder app is free to download and use, there are no costs to users at the point of download and there are no purchases within the app.
4. To participate in an Ale Trail on the Cask Finder app a user must be the minimum of 18 years old.
5. Postage of any prize is only included to addresses in the UK.
6. Employees of the Cask Marque Trust or sister companies are excluded from receiving prizes from participation in an ale trail but can still participate.
